## Opening Keynote

### Behind Dark Waters: A Keynote Conversation with Environmental Attorney Robert Bilott

Robert Bilott was a corporate defense attorney for eight years until he took on an environmental suit that upended his entire career — and exposed a brazen, decades-long history of chemical pollution. He shares the story of his epic 20-year legal battle against DuPont, which inspired the major motion picture *Dark Waters* (Nov. 2019), that consumed his life and exposed the worst case of corporate coverup and environmental contamination in modern history. To date, Bilott — a partner at Taft Stettinius & Hollister LLP — has helped secure over \$1 billion in benefits for his clients exposed to contaminated drinking water. Among his many honors, Bilott was selected as one of the best lawyers in America for several years running and in 2017 received the Right Livelihood Award, commonly known as the “Alternative Nobel Prize.”

## Joint General Session

### Navigating and Optimizing Progressive Design-Build

The growth of design-build can be attributed, in part, to the flexibility of design-build, but also to the rapid emergence of Progressive Design-Build (PDB). Over the past two years, we've seen increased interest in the use of PDB as demonstrated by numerous states either allowing PDB via interpretation of existing legislation or enactment of legislation specifically addressing PDB. Owners are employing PDB at a continually increasing rate, with recent FMI research revealing that stakeholders in the Pacific census region indicated 40% of design-build projects are procured using a progressive approach. Add to this the fact that over the last decade, infrastructure projects have grown larger, more complex and with increased risk, and you'll find that Owners and design-build teams are turning to PDB to mitigate cost and schedule risks. In this session you will:

- Discuss the key distinguishing factors of PDB.
- Learn how to determine if an Owner and/or a design-build team has the characteristics and culture to be successful in a PDB environment.
- Hear common pitfalls to PDB success and how to work collaboratively to identify and mitigate them.
- Understand PDB legislative authority, including the role of a cost component in determining authority.

### **Where the Robots Meet the Road with Greg Lindsay**

A decade ago, self-driving cars were science fiction left-over from The Jetsons. Today, Google and Tesla are leading a breakneck autonomous arms race, as the global auto industry races to build electric AVs at a cost of hundreds of billions of dollars. 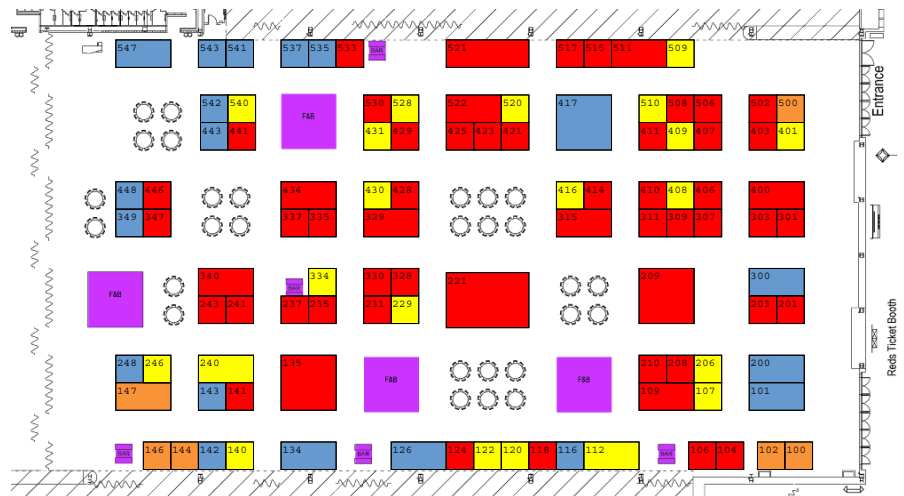

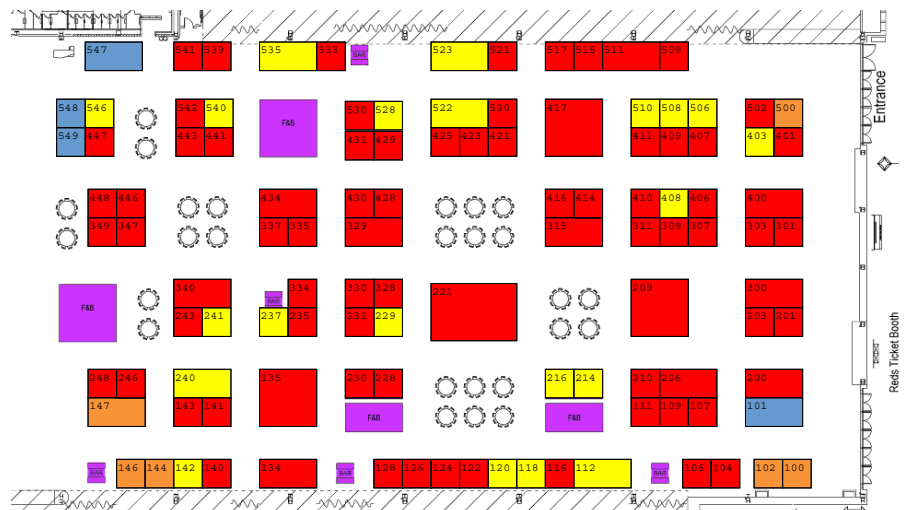
