# 4. Design-Build Activities from Online Transcript

DBIA elective courses, along with live and recorded webinars and conferences, as well as pre-approved events from DBIA Regions and Chapters, will be automatically displayed for the past two years. If you notice any missing activities, report them in the next step under "Design-Build Activities." DBIA will confirm these during the review process.

Include any additional design-build activities completed within the past two years. Transcripts or certificates are not required at the time of submission; however, DBIA may conduct audits and request supporting documentation if necessary.

### 6. DBIA Leadership

Serving on DBIA Boards, Committees, Award and Competition Juries, or Region Boards qualify for Continuing Education Hours (CEHs). A maximum of 12 CEHs may be accrued in this area.

Education offered by related industry organizations — such as USGBC, AIA, AGC, ACE and others — is eligible if it relates to design-build project delivery. A maximum of 12 CEHs may be accrued in this area.
